#### 22/22 Diversity and Inclusion data in resear@them 6a]

The Board received a report covering some researchated diversity and inclusion data across the following areas: staff demographics; representation amongst Research Division Leaders and committee membership; research awards and applications; researchests; dand research output volume. In particular, it noted the following:

- Generally, Females' average research award and application values were lower than Males, and the proportion of award/application value was lower than the proportion of Females in Research Divisions

The Board receiver information a copy of the policy, which had been reviewed at the Board's previous meeting, and had now been agreed by UEB. Members remained concerned about the potential for acceptance of funding agreements to result in censorship or constraints.

#### 22/33 Research Travel Grant[stem 9d]

The Board received the annual report from the Research Travel Grant Subnittee, which oversees the allocation of awards to support conference attendance and other research travel.
